#### **Public Participation and Accessibility**

#### Golden Empire Transit District Board of Directors Meetings

On March 17, 2020, Governor Gavin Newsom issues Executive Order N-29-20, which includes a waiver of Brown Act provisions requiring physical presence of the Board of Directors or the public in light of the COVID-19 pandemic. Based on guidance from the California Governor's Office and Department of Public Health, as well as the County Health Officer, in order to minimize the potential spread of the COVID-19 virus, the Golden Empire Transit District Board of Directors hereby provides notice that as a result of the declared federal, state and local health emergencies, and in light of the Governor's order, the following adjustments have been made:

- Board of Directors meetings will have limited public access to maintain social distancing.
   Face coverings will be required to attend the meeting in person.
- Consistent with the Executive Order, Board Members may elect to attend the meeting telephonically and participate in the meeting to the same extent as if they were physically present.
