# Reuniones de la Junta Directiva de Golden Empire Transit

El 17 de marzo de 2020, el gobernador Gavin Newsom emite la Orden Ejecutiva N-29-20, que incluye una exención de las disposiciones de la Ley Brown que requieren la presencia física de la Junta Directiva o del público a la luz de la pandemia COVID-19. Basado en la orientación del Gobernador de California Oficina y Departamento de Salud Pública, así como el Oficial de Salud del Condado, con el fin de minimizar la posible propagación del virus COVID-19, la Junta Directiva del Golden Empire Transit por la presente notifica que, como resultado de la declaración de salud federal, estatal y local emergencias, y a la luz de la orden del Gobernador, se han realizado los siguientes ajustes:

- Las reuniones de la Junta Directiva tendrán acceso público limitado para mantener el distanciamiento social. Se requerirá cubrirse la cara para asistir a la reunión en persona.

## Public Participation and Accessibility Golden Empire Transit District Board of Directors' Meetings

- All public comment sent in by the above methods will be provided to all Board members and applicable staff, for review and consideration by the Board prior to taking any action on any matters and will be incorporated into the official record of the Board meeting.
